

## Minutes for the Ordinary Meeting of the Aislaby Middleton and Wrelton Parish Council held at The Village Hall, Wrelton on Tuesday 20 September 2016 at 7.30pm

1 Apologies for absence were received and accepted from Cllr Lumley

2 There were no Declarations of Interest in items on the agenda

3 Minutes and Matters arising:

a) The minutes of the meeting held on 23 August 2016 were approved

b) There were no matters arising from the meeting 23 August 2016 not covered elsewhere on the agenda

4 Members of the public made representation regarding land issues regarding sewage overflow into land adjacent to Eastfield House and Crooke Cottage, Cliff Rd, Wrelton. This has occurred 7 times since July 2016 and although Yorkshire Water is informed and engineers have attended the problem persists. The issues are more often at night. The council were informed that no telemetry was in place. The land which floods also contains a well containing spring water.

Councillors requested the Clerk contact Yorkshire Water, the Environment Agency and NYCC with the additional information received at the meeting

Broken Drain on Aislaby Carr Lane (ref 101002894455) – Cllr Peirson to follow up

Surface water drainage on Aislaby New Lane – work completed, item to be removed from list

Street lamp repairs to lamps 17, 19 and 20 Back Lane, Middleton – not done as yet, Clerk to chase

Tree maintenance opposite Middleton Village Hall.- job partially completed but not to required height given agricultural impact

Blocked Bridleway from Middleton Nova Lane along Broates Lane

Wrelton; overflow of sewage into the backs of the gardens along Cliff Road. Covered under public session.

Footpath – eastern side of Main Street in Wrelton, tarmac covering degenerated to the point of wheel chair manoeuvrability impaired.

Footpath between Aislaby and Middleton north side is severely overgrown

Request to County surveyor to come and review the quality and degeneration of footpaths in Wrelton specifically but over view across the full Parish
