8. General Maintenance/villages
  - a) Back lane Wrelton – No further information received.
9. Councillor Baird volunteered to investigate further into the legal position of both and to ascertain the landowners on either side of Cliff lane and Dams Lane in regards to the DMMO application.
10. After discussion and review of the existing number of dog waste bins in Middleton and their locations, it was suggested that, rather than a new bin, the current one sited south of the properties on Middleton Carr Lane should be re-sited at the junction of the Lane and Back Lane South on the area by the Pond.
