 - b) Incomplete road works on New Lane, Aislaby Although Cllr. Lumley could not be present, he had sent a photo of these works. It shows that although further work has been done, the repairs are not finished properly. Highways to be notified.
- 9. Photographs of the Wrelton village signs were shown. One (on Old Road) is broken (the result of either vandalism or attempted theft) and others are rusting/pitted. It was decided to report this to the local authority, in this case and request replacement, initially of the broken one.
- 10. The request for pond maintenance from Middleton village hall. Discussion of the long term future of the pond and its maintenance and finance followed. Any decision was to be delayed whilst this was discussed further with the Village Hall Committee, including the possibility of a permanent transfer to the Village Hall Committee with all responsibilities for its maintenance.
