- 1. Apologies: Cllr. Cook.
- 2. There were no declarations of interest in item on the agenda.
- 3. a) Minutes of the previous meeting held on 19th April 2022 were approved.

- 4. Previous councillors A & C Robinson have applied for vacant positions on the council.  - c) Street lighting issues and repairs progress *Street lighting issues not yet resolved, despite Highways claiming they are. To be re-reported and left on the agenda..*
- 12. Delegated matters:
 - a) Report of the broken Wrelton Village sign Signs ordered. Their fixing to be discussed when signs are delivered.
 - b) Legal costs of transfer of ownership of the land at Middleton Village Hall Pond noted to be £500+VAT with survey costs on top. To be funded out of the pond fund with anything over that amount funded by Middleton Village Hall, this to be confirmed with Middleton Village Hall committee via Stuart Plant. Estimated to be approx. £167.
 - c) Request for "No through road" sign for New Lane Aislaby agreed to be submitted.
- 13. A report of a site of Japanese Knotweed in the parish has been received from a parishioner. The site owner is aware and has started remedial action, but the Council wish to monitor progress, so this item will be included in the general maintenance item on the next agenda.

It was noted that a 30mph sign in Wrelton. It was agreed to report this to Highways.

It was noted that the sharp right hand bend sign on Cropton Lane approaching the village is obscured by the hedge. It was agreed to report this to Highways.
