- b) Pruning of walnut tree at top of Carr Lane Middleton. *Cllrs. Lumley* & *A. Robinson volunteered to complete.*
- c) Street lighting issues and repairs progress.
 Light 10 Middleton (South side opposite Nova Lane). *Repaired*.
 Light 11 Middleton (South side near Middleton Carr Lane). *Repaired*.
 Light 5 Middleton (North side near Foxglove Cottage). *Reported back as major work required no further information on completion*.
 Light 4 Aislaby (Outside Evelyn Lily). *Reported back as major work required no further information*.
- d) Japanese Knotweed in Beadale Wood. Work in progress by landowner, *Council to monitor.*
- e) Sharpe Right Bend sign on Cropton Lane, Wrelton obstructed by hedge. *Highways Area 4 is now aware of the problem. They are contacting the hedge owner whose responsibility it is, to resolve the issue. To be monitored.*
- f) Faded 30mph sign in Wrelton. *No further information.*.
- g) Replacement of Wrelton Village signs. These are still on order. Their delivery includes installation. Council to ensure that the correct signs are replaced upon delivery.

b) Ryedale District Council Planning explained the use of planning of decided / determined status as:

"When the Council is given notice to carry out work on trees in conservation areas the applicant is advised that the Council has 6 weeks from the date of receipt of their notice to consider making a Tree Preservation Order in respect of the trees. If they have not heard from the Council they may carry out their proposals provided that do so within 2 years from the date of the notice. The process is as follows:

Application validated, Applicant sent acknowledgement and advised of timeframes, Parish Council Consulted, Site visited by Tree Officer, Comments considered, Decision to make order, Application determined".
