## Of the Ordinary Meeting of the Aislaby Middleton and Wrelton Parish Council held at Wrelton Village Hall on Tuesday 22<sup>nd</sup> November 2022 at 7.30pm

- 1. No intention to record the meeting was given.
- 2. No Apologies; all councillors present.
- 3. There were no declarations of interest in item on the agenda.
- 4. a) Minutes of the previous meeting held on 18<sup>th</sup> October 2022 were approved.

- 5. Mr Lee Thompson was present, in respect of his application to join the Parish Council.

- g) Damage to culvert bridge on Marton Lane Noted as repaired with wooden rail, Council to wrote complaint as to the repair suitability and quality.

  - b) Report of building/renovation work been carried out on Lane End Cottage at the bottom of Shop Lane, Aislaby. Chairman checked with Ryedale District Council that planning applications had been submitted for work carried out on this listed property. No such applications appear to have been received, so this matter is now left with Ryedale District Council to deal with.
- 12. The Chairman informed the committee of receipt of a letter from Ryedale District Council requesting information on our use of community infrastructure levy (CIL) received. This money is intended for use on capital projects, but with no pressure on timescales. It was decided to respond that currently we had nothing in the pipeline but that some planned maintenance issues would require funding.
