- 9. General Maintenance/Villages.

To receive information on outstanding maintenance and note maintenance issues brought to the meeting for reporting.

- a) Street lighting issues and repairs progress (Ref: 101009276368). No further information received.
 - Light 5 Middleton (North side near Foxglove Cottage). Light 4 – Aislaby (Outside Evelyn Lily).
- b) Japanese Knotweed in Beadale Wood. Photos of the site taken last week were shown. Cllr. Lumley is to contact the person treating this and obtain a name so that the Parish Council can continue to monitor.
- c) Sharpe Right Bend sign on Cropton Lane, Wrelton obstructed by hedge. The sign appears to have been moved, therefore, the problem is solved and will be removed from future agenda.
- d) Faded 30mph sign in Wrelton. – No further information received.
- e) Road repairs on 12Aug2022 at Goshen, Wrelton.- Cllr. Quinlan drafted a letter to Highways which is awaiting approval before dispatch.
- f) Road subsidence on A170 near Wrelton. Road subsidence worsening noted that vehicles were being thrown across the centre white line onto the oncoming carriageway. Cllr. Quinlan to draft a further letter (Chairman to approve) for submission to Area 4 Highways.
- g) Damage to culvert bridge on Marton Lane. No further information received.
- h) Road markings at Middleton cross roads Nova Lane, Chruch Lane, High Back Side. (Ref: 101009795395). Reported to highways, no further information received.
- i) Aislaby Carr Lane collapsed drain (ref: 101009795401). Reported to highways, no further information received.
- 10. To receive reports from Councillors on delegated matters.
 - a) Middleton Pond ownership and land transfer. *No further information received Cllr. A. Robinson to contact solicitors Pearson & Ward to check transfer is completed.*
- 11. Cllr. Lumley commented on New Lane, Aislaby approach to Highfield Grange is breaking up. This work was only done recently (within the last two years). Cllr Lumley to approach Highways.

Cllr Quinlan commented on the amount of recycling material on roads and roadsides on the day after recycling collection. Suggested that he drafted a letter to Refuse & Recycling dept. to check if this could be reduced.

Cllr. Cooke queried whether the Parish Council should be inputting thoughts to the Ryedale Plan, the closing date for which is 21.02.23 (the date of our next meeting). Most councillors had either not read it at all or only in parts. It was agreed that all would do so, submit their thoughts and comments to the chairman over the next weeks and that it would be discussed at the next meeting. Anything felt to be relevant to be submitted to the comments website by the chairman direct from the meeting before the closure date.
