Minutes

Of the ordinary meeting of the Aislaby, Middleton and Wrelton Parish council held at Wrelton Village Hall on Tuesday 24th June 2025 at 7:30pm

- 1. No intention to record the meeting was given,
- 2. Apologies received from Cllr. Thompson.
- 3. There were no declarations of interest.

- 5. Mr. & Ms. Scaling (Keld Knowle Farm, Wrelton) attended. They explained the reasoning behind their planning application (item 6a (i) below) and asked for Parish Council support. They asked if they should withdraw for the council's discussion but were invited to stay..
- 6. Planning (and related items).
 - a) To receive information regarding planning applications received from Ryedale District Council and NYC:
 - i) Change of use of land to form a retail area for the sale of farm milk and associated products via self service vending machines along with other local produce. Provisions for 30No. carparking spaces along with 2No. steel containers for the housing of equipment including low level lighting.

Following discussion, plus further questions put to the applicants, it was decided to actively support this application on grounds of encouraging local business, adding a source of local produce to this area, and the lack of any apparent environmental damage/loss of productive agricultural land. Traffic management was also discussed and the council felt that any increased traffic flow would not create any further dangers than already exist on the A170.

- 9. General Maintenance/Villages.
 - To receive information on outstanding maintenance and note maintenance issues brought to the meeting for reporting.
 - a) Street lighting issues and repairs progress. Continuing to monitor.
 - b) Japanese Knotweed in Beadale Wood. Continuing to monitor.
 - c) Blocked drain on Carr Lane Aislaby, (ref: 101010791717). *No further information received.*
 - d) Condition of footpath between Aislaby and Wrelton along northern side of A170. *Continuing to monitor.*
 - e) Drainage ditch on Marton Lane/Street Lane with no safety barrier One safety barrier has been erected, although not where the Council reported the problem. The original and one further potential dangerous unprotected points have been identified and reported to Highways.
- 10. Request to trim the tree on Wrelton Main Street village green noted. Considered that height was no problem, but that lower branches should be removed to enable safer grass cutting. Cllr. Quinlan to action.
- 11. Review of grass-cutting around the villages, Council was happy with work carried out so far. Contractor to be asked to also cut High Back Side Middleton.
- 12. Review of VAS installation and consider proposed survey of villagers thoughts/suggestions on road safety measures given by Cllr. Taylor.
 Cllrs. had received, prior to the meeting, details of the meeting of Cllrs. Peirson and Taylor with deputy mayor of the combined York & North Yorkshire Authority, Jo Coles. Clrr Taylor has drafted a summary of potential traffic-calming measures for the A170, in conjunction with the local PCSO, which the deputy mayor took on board. The Council expressed its appreciation for the work carried out and resolved to continue to campaign for further measures. No further info has been received regarding the VAS installation,
