- General Maintenance/Villages.
  - To receive information on outstanding maintenance and note maintenance issues brought to the meeting for reporting.
  - a) Street lighting issues and repairs progress. Wrelton covered by Cllr. Quinlan. Problems, particularly lamp no.2 (opposite Wrelton Village Hall) which is shown on the Highways map but which was removed at least 18 months ago and never replaced, were reported on the NYC Highways 'Street light problems' website. Problems varied from failure to replace one old lamp with new LED, remove old concrete lampposts (2), to timer settings on lamps due to switch off at 12 midnight which don't.
    - Middleton and Aislaby still to be checked and problems, if any, reported by Cllrs resident in those villages.
  - b) Japanese Knotweed in Beadale Wood. *Continuing to grow spraying to continue and further monitoring.*
  - c) Blocked drain on Carr Lane Aislaby, (ref: 101010791717). *No further information received.*
  - d) Condition of footpath between Aislaby and Wrelton along northern side of A170. *Continuing to monitor.*
  - e) Drainage ditch on Marton Lane/Street Lane with no safety barrier *No further information*.
    - A discussion took place regrading the increasing encroachment of soil from fields onto the lower stretches of Cropton Lane, Wrelton (Gibson's Quarry to Cawthorne Lane) resulting in significant further narrowing of an already narrow, winding and busy road was noted. Highways to be informed of Health & Safety issues involved. Discussion regarding replacement of 'Elsie Fletcher's' bench on Wrelton green due to weathering damage. Cllr. Peirson volunteered to provide a replacement free of charge. To be added to next meeting agenda.
- **10**. A discussion on the Aislaby notice board took place. No decision was taken so deferred to next meeting.
- 11. Cllr. Peirson has offered replacements for both of the benches in Wrelton free of charge. As one is dedicated to a previous village resident, enquiries to be made to determine original owners and any objections to replacements. Dedication to be transferred to new bench if approved.
- 12. No further update on VAS installation and safer spaces campaign.
- 13. To receive reports from Councillors on delegated matters.
  - *a)* Information regarding the status refused retrospective listed building application for Pear Tree Villa, Wrelton.
