- 8. Financial Information. Cllr. Quinlan had noted the broken stile on the public footpath to the east of Cliff Lane. Suggestion that this is reported to NYC Footpaths.

 - b) Budget for 2026/2027 was proposed on the basis of this years spending with sufficient reserves to cover unexpected expenses, such as the recent notification by North Yorkshire Council of recharges to parish councils of contested elections expenses. This considered unlikely for this Parish Council but sufficient reserves are in hand.

- c) After discussion, it was agreed that our precept should rise in line approximately with the RPI, currently at $^{\sim}4\%$. A figure of £1250 was agreed.
- 10. General Maintenance/Villages.

To receive information on outstanding maintenance and note maintenance issues brought to the meeting for reporting.

- a) Street lighting issues and repairs progress. no further information.
- b) Japanese Knotweed in Beadale Wood. Likely to be dying back shortly but to leave on the agenda to monitor.
- c) Blocked drain on Carr Lane Aislaby, (ref: 101010791717). Work completed.
- d) Condition of footpath between Aislaby and Wrelton along northern side of A170. Condition to be monitored. In response to our request, the lowest two strips of the field have been ploughed east to west (rather than north to south) to attempt to prevent, or at least reduce, the runoff onto path and road, and retain more soil on the field.
- e) Drainage ditch on Marton Lane/Street Lane with no safety barrier Work completed.
- f) Increasing encroachment of soil from fields onto the lower stretches of Cropton Lane, Wrelton (Gibson's Quarry to Cawthorne Lane) resulting in narrowing of road. Concluded that insufficient narrowing has occurred and thus will take no action.
- g) Overgrown hedge on Costa Lane Middleton Millenium Wood. (ref: 101011195184) Highways have passed this to Tilhill who are responsible for maintenance of this hedge. Cllr. Thompson volunteered to contact the Woodland Trust which is responsible for the conditions within the Millenium Wood.
- 11. Replacement or repair of the Aislaby notice board was discussed. Cllr. Quinlan volunteered to attempt to price up a suitable replacement.
- 12. As agreed, a request for information on ownership of the Wrelton main street green and Goshan benches has been placed in 'The Wrambler' and responses are awaited. The chairman of the Village Hall committee has agreed that the benches offered are suitable replacements should there be no objections.
- 13. No further update on VAS installation, chairman to chase up Cllr. Taylor has had no further information on the 'Safer Spaces' campaign as the funding for this is awaiting approval by North Yorkshire Council.
