- a) Street lighting issues and repairs progress. Noted that all the lamps in the parish have not been upgraded. Remaining task is the removal of the last two old concrete lamp posts in Wrelton.
- b) Japanese Knotweed in Beadale Wood. Re-monitor in Spring.
- c) Condition of footpath between Aislaby and Wrelton along northern side of A170. *Condition to be monitored.*
- d) Overgrown hedge on Costa Lane Middleton Millenium Wood. (ref: 101011195184) Awaiting response from Tilhil.

- e) Broken stiles. No checks have been made on progress of repairs due to recent inclement weather.
- f) Wrelton benches. -No further action due to weather conditions. Work will probably be undertaken in the spring next year.
- g) Aislaby notice board. Refurbishment and repaint not yet done due to weather conditions. Work likely to be carried out in the spring next year.
- 10. Safer Spaces: nothing further.

VAS installation: The mounting post on the north side of the A170 in Aislaby has been installed and electrically connected. However, it has been installed too close to the telegraph pole to allow the sign when installed, to be turned to face east at times, as was originally planned. Although unfortunate, this is not a disaster. Unlike the situation in Middleton: here the agreed location of the VAS was mounted to the new lamppost opposite St. Andrew's church. Due to several of these new lampposts falling over, North Yorkshire Council have decreed that nothing shall be attached to any more, leaving the Parish Council having to pay for the installation and electrical connection of a separate post to mount the sign on. Councillors agreed to this extra expense as basically we have no choice. More worryingly, the authorized supplier of the signs has gone into administration, leaving many purchasers, which had ordered and paid for their signs, potentially very out of pocket. Fortunately, due to yet another misunderstanding by our local highways dept., they had not ordered (or paid for) our sign, so perhaps fortunately this Parish Council is not in that position and so will be able to purchase a sign when North Yorkshire Council appoint another suitably vetted and approved supplier.
