

## Minutes

### Of the ordinary meeting of the Aislaby, Middleton and Wrelton Parish council held at Wrelton Village Hall on Tuesday 30<sup>th</sup> December 2025 at 7:30pm

1. No intention to record the meeting was given,
2. Apologies received from Cllr. Baird, Cooke & Taylor.
3. There were no declarations of interest.
4. a) Minutes of the previous meeting held on 25<sup>th</sup> November 2025 were approved with correction to item 9a ("not" to "now").  
b) No matters arising not on the agenda.
5. Two members of the public present - Sarah Hooper & Keith Dunning.  
Having had the role of a Parish Councillor and the function of the Parish Council explained, Ms. Hooper applied for the vacant position on the council for Middleton. Having spoken to the councillors present, no objections were raised to Ms. Hooper joining the council ; she was therefore co-opted and joined the meeting. 6. Planning (and related items).  
a) To receive information regarding planning applications received from Ryedale District Council and NYC:  
  
i) Removal of 4no. dormer style structures on the roof, re-tiling with matching reclaimed 'cowshed' pantiles. Replace existing cast concrete lintels above windows on all elevations with yorkshire stone. Remove cast concrete lintel above garage door and replace with green oak beam. Replace oversized window and wooden cill above garage for a smaller, more traditional style (matching existing) with a stone cill and lintel.

- c) Condition of footpath between Aislaby and Wrelton along northern side of A170. – *Condition to be monitored.*
- d) Overgrown hedge on Costa Lane Middleton Millenium Wood. (ref: 101011195184) - *Case no. quoted closed by North Yorkshire Highways. Cllr. Thompson suspects that although work has been carried out, it will be inadequate to solve the problem in the near future. To be removed from the agenda at present.*
- e) *Broken stiles. - Completed.*
- f) *Wrelton benches. -No further action due to weather conditions. Work will probably be undertaken in the spring next year.*
- g) *Aislaby notice board. - Refurbishment and repaint not yet done due to weather conditions. Work likely to be carried out in the spring next year.*
