8. a) The financial statement was approved.

9. General Maintenance/Villages.

To receive information on outstanding maintenance and note maintenance issues brought to the meeting for reporting.

- a) Street lighting issues and repairs progress. – *No progress on issue of removal of two remaining concrete lampposts in Wrelton. Reminder/request sent to Highways from the meeting*
- b) Japanese Knotweed in Beadale Wood. – *Monitor in Spring then the area infected is to be sprayed with Grazon Pro in (March/April)..*
- c) Condition of footpath between Aislaby and Wrelton along northern side of A170. – *Condition ok considering recent heavy rains - much improved on previous years. Seems to suggest that ploughing east/west on the bottom of the field is having the desired effect. Thanks were expressed to Cllr. Lowery for giving this a try. Continue to monitor.*
- d) Wrelton benches. -*No further action due to weather conditions. Work will probably be undertaken in the spring next year.*
- e) Aislaby notice board. - *Refurbishment and repaint not yet done due to weather conditions. Work likely to be carried out in the spring next year.*

10. The VAS has been ordered with an expected delivery time of 4-6 weeks. As yet, the new mounting pole with electrical connection in Middleton has not been placed.

The Safer Spaces campaign - no more information received. Cllr. Taylor has investigated and found that any bid for money from the recently released fund must be match funded by the applicant. This effectively rules out our Parish Council on grounds that we have insufficient reserves to match any application for work of significant impact, and we have already set our precept for the next financial year..

12. Message received from Middleton, Lancaster Parish Council regarding their receipt of emails sent to them in error from a resident of our parish. This was in respect of vehicles parking on the A170 through Middleton on grass verges, on pavements causing blockages, and on vehicles parking on the road at night without lights, as required by law in a 40mph limited zone. From previous experience, the Parish Council is aware that North Yorkshire Police will not take any action to enforce/ deal with these infringements. The chairman to contact, via email, the resident to this effect and also to point out the correct email address for this PC.

Cllr. Hooper requested that an extra dog-waste bin be provided at the top of Goshen, at the site of the bench. When a previous request was made, it was thought that the cost to the Parish Council was approx.£80 . Allowing for inflation, this was considered to be a sensible request, the cost agreed by councillors. The chairman to enquire to North Yorkshire Council.
